*The special designation of Benefactor is given to businesses whose total **cumulative giving** is \$150,000 or more.*

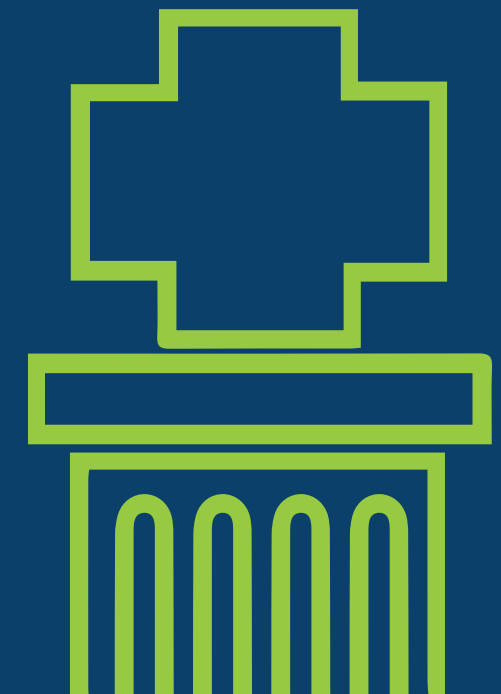
